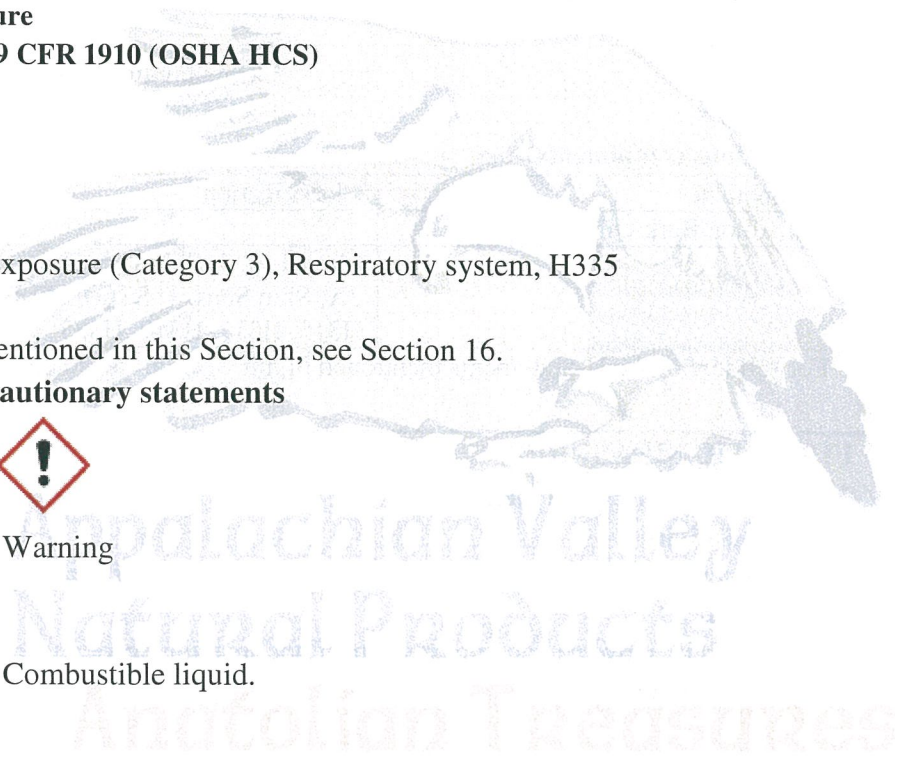

5. FIREFIGHTING MEASURES

5.1 Extinguishing media

Suitable extinguishing media

For small (incipient) fires, use media such as “alcohol” foam, dry chemical, or carbon dioxide. For large fires, apply water from as far as possible.
